1. Chapter experts

More than two-thirds of all chapter authors are now established, and the Committee are now working on establishing the last authors. Many authors have already started updating the chapters, and the first chapters will be finalized mid-2021. The more extensive chapters will be finalized primo 2022. The public call for experts will be open until all chapter authors are established. When all chapters are established, all chapters and authors with names and affiliations will be available at the NNR2022 official web-page.

2. Scoping Reviews

To develop candidate topics for prioritization of *de novo* systematic reviews, members of the NNR Committee have performed scoping reviews (ScRs) for all the nutrients and food groups considered in the NNR2022 project. All but one ScR is now completed. The ScRs will be available for the chapter authors.

3. Discuss PI/ECOTSS for Systematic Reviews

The Committee will prioritize 10 PI/ECOTSS for Systematic Reviews (SRs). The PI/ECOTSS for topic two to five was adjusted at our previous meeting after comments from the SR Centre. Further adjustments are still required, and the Committee are now in the final process for finalizing these. The results of this process will be published in a scientific article in *Food & Nutrition Research* shortly. The protocols will be developed during the next months. All protocols will be published in PROSPERO. The last priorities will be initiated by mid-2021. Before initiating the last SRs, another Delphi round with ranking among the NNR2022 Committee will be performed.

4. End date for searches

The NNR2022 Committee discussed the end date for literature searches for the chapters. A section regarding this issue will be included in the "Instruction for authors". The end date for searches will be set as late as possible before the chapter authors submit the chapters to the NNR Committee. An update search will also be performed. In the case of new evidence that may have potential to change the DRVs or FBDGs, this must be discussed specifically.

5. Formulation of sustainable FBDGs: How specific should the guidelines be formulated?

The NNR2022 Committee plan to develop three background papers that will serve as a fundament for integration of sustainability in NNR2022. The third paper will implement aspects from the two first papers into the health-based food based dietary guidelines (FBDGs). The Committee discussed today how specific the formulation of the FBDGs should be and how much flexibility the national authorities in the Nordic and Baltic countries should have when they formulate national sustainable FBDGs. This is a discussion that will be raised several times and will also involve the Steering Committee.
