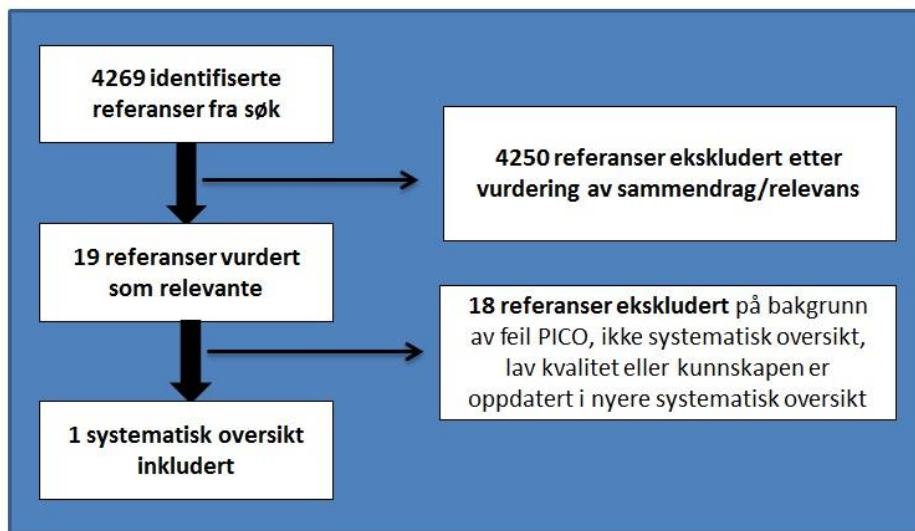
P – Pasienter med bulimia nevrosa

C – Placebo

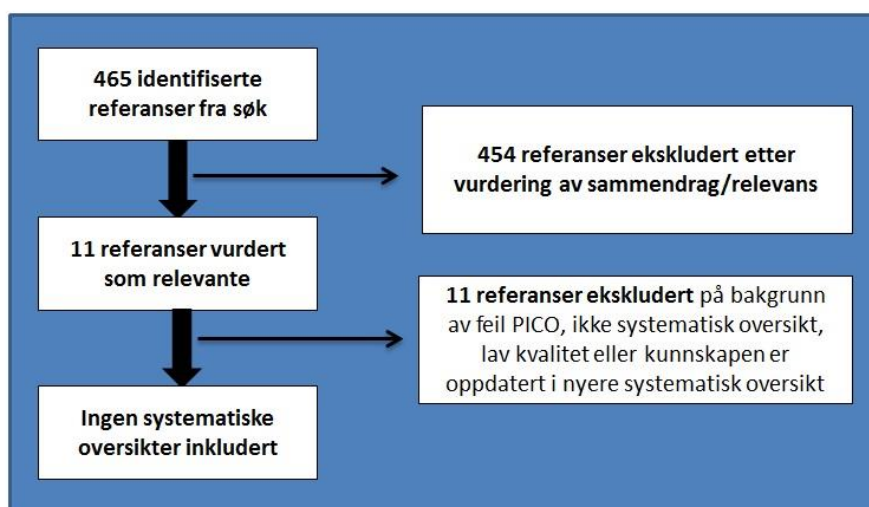
